The purpose of this modification is to exercise the first option year of the contract. Therefore, the contract is modified as follows:

1. Pursuant to Section I.63, "Option to Extend the Term of the Contract", Option Period 1 (June 1, 2007 to May 31, 2008) is hereby exercised. As a result, CLIN 0002 under Section B.2, "Estimated Cost Plus Fixed Fee" is hereby invoked. The estimated DPLH for this period is 92,120 as specified in Paragraph B.4. entitled "Level of Effort/Direct Productive Labor Hours (DPLH)." The performance incentive fee pool for the option period is also invoked as stipulated in clause B.3.
2. As a result of item 1 above, the total estimated cost-plus-fixed-fee of the contract is hereby increased by EX 4 for the option period 1 period of performance. The total contract value is also increased by EX 4 for the performance-based incentive fee. The total contract value of \$6,494,376.00 is hereby changed to read \$9,863,834.67, an increase of \$3,369,458.67.
3. A revised US Department of Labor Wage Determination will be requested when the Electronic SF-98 system is available, and incorporated in the contract for this option period when received from the DOL.
