Description:

- B3.6** Siting, construction (or modification), operation, and decommissioning of facilities for indoor bench-scale research projects and conventional laboratory operations (for example, preparation of chemical standards and sample analysis); small-scale research and development projects; and small-scale pilot projects (generally less than two years) conducted to verify a concept before demonstration actions. Construction (or modification) will be within or contiguous to an already developed area (where active utilities and currently used roads are readily accessible).
- A9** Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.

Rational for determination:

DOE is proposing to provide federal funding to the University of Delaware to conduct laboratory research and development activities on thin film solar cells. The proposed project would 1) determine how sodium improves CIGS device performance and 2) demonstrate a sodium incorporation scheme that gives equivalent performance levels.

All research, prototype fabrication and testing would occur in a laboratory environment within university facilities including the University of Delaware and the University of Illinois. Both facilities have completed an R&D questionnaire addressing the protocols in place regarding laboratory safety, risk management, chemical handling and waste disposal. Both facilities comply with standard laboratory safety procedures and labs are inspected by university staff and safety personnel. The safety protocols are monitored by the University's Environmental Health and Safety Offices.

Both universities have all applicable operating permits in place for research conducted on campus. Liquid effluents consisting of solvents, acids, bases, chemical reagents, and other liquid wastes will be disposed of by licensed contractors.

Based on this information, DOE has determined the work outlined is consistent with activities identified in categorical exclusion A9 (information gathering) and B3.6 (indoor bench-scale research and conventional laboratory operation).
