**Rational for determination:**

SolarTech is proposing to use DOE funding to develop standardized approaches for reducing non-hardware balance of system costs (e.g. permitting, interconnection, etc.) for PV deployment. SolarTech will engage in outreach and planning with outside entities, non-profit organizations, and public officials to develop the best path forward. Activities would involve training, data collection and analysis, materials development, program design and model development. In addition, DOE and cost-share funding would be used to support the dissemination and implementation of the developed models at national level as directed by DOE.

DOE has determined that impacts to the natural and human environments are expected to be negligible and that this project is consistent with actions covered under DOE CX A9 (information gathering, data analysis, document preparation and dissemination) and CX A11 (planning assistance to national, state, and local organizations) and therefore is categorically excluded from further NEPA review.
